Declaration of responsibility - Please read carefully!

As a declarant indicated above and as a driver participant of the **TRACK DAY PROGRAM** (hereinafter referred to as the **Event**) organized by HUNGARORING Sport Zrt. (registered office: 2146 Mogyoród Hungaroring út 10. Tax number: 10603226-2-44, company registration number: 13-10-040464, represented by: Zsolt István Gyulay, President and CEO; hereinafter referred to as the "Organizer" or "HUNGARORING Sport Zrt.") at the Hungaroring Circuit (hereinafter referred to as the **Circuit**), I hereby declare, in full awareness of my criminal and civil liability, that during the Event:

- I acknowledge that only persons who have reached the age of 18 may participate in the Event; if I am accompanied by a minor to the Event, I acknowledge that I am solely responsible for the minor and for any damage caused by the minor, and that HUNGARORING Sport Zrt., as the organizer of the Event, and its directors, employees, and agents bear no liability whatsoever for the minor, and such liability is hereby excluded;
- I participate in the Event with my own vehicle at my own risk and liability, and I will drive the vehicle in full compliance with the instructions of the employees and agents of HUNGARORING Sport Zrt.;
- I declare that if I am participating in the Event with a vehicle not owned by me, such participation is taking place with the knowledge and consent of the vehicle's owner; I further declare that the vehicle's owner does not expressly prohibit the use of the vehicle on the Circuit, accordingly HUNGARORING Sport Zrt. excludes all liability in the event of a false statement made by the participant regarding the matters set forth in this point, with respect to any and all claims arising on the part of the owner of; the vehicle/motorcycle
- I acknowledge that the scope of the compulsory motor vehicle liability insurance and the possible CASCO **insurance** concluded for motor vehicles **does not extend to** the Circuit based on the insurance provider's business rules and the insurance policy, therefore it is my own responsibility to check this and **bear any risks resulting from this**, and I am aware of this when participating in the Event;
- during the Event, I use the entire area of the Circuit (including the track and its facilities, the entire premises of HUNGARORING Sport Zrt., located at 2146 Mogyoród, Hungaroring út 10) exclusively at my own risk and responsibility;
- I am fully aware of and accept all risks associated with my participation in the Event;
- I have familiarized myself with the rules regarding the conduct of the Event and participation therein, which were provided to me in advance by the Event organizer; I have understood and acknowledged the contents thereof and I will fully comply with them throughout my entire stay at the Circuit; the Event organizer, its directors, employees, and agents shall NOT be liable for any injuries or damages resulting from failure to comply;
- I acknowledge that the scope of the compulsory motor vehicle liability insurance and the possible CASCO insurance concluded for motor vehicles does not extend to the Race Track based on the insurance provider's business rules and the insurance policy, therefore it is my own responsibility to check this and bear any risks resulting from this, and I am aware of this when participating in the Event:
 - On the race track, I will comply with the flag signals and instructions of the coordinating staff (Yellow flag – danger very close to the race track, reduce your speed! Double yellow flag – danger on the race track, drastically reduce your speed, prepare to stop! Red flag – the event is suspended; return to the pit lane at reduced speed! Green flag – the race track

- is clear; yellow-and-red striped flag – the grip conditions have changed in the section following the signal; the race track surface is slippery; Checkered flag – the session is over; return to the pit lane or the paddock
- (ii) In addition to the driver, a maximum of one passenger may travel in the vehicle, provided that this person has previously signed a liability declaration;
 - (iii) If you notice any danger that threatens your safe continuation of driving, pull over to the side in the safest location and immediately leave the area within the primary line of defense, report the problem to the coordinating personnel, or turn on the hazard warning lights on your vehicle;
 - (iv) The use of seat belts is mandatory throughout the entire program; windows must be rolled up;
 - (v) It is strictly prohibited to remain outside the vehicle within the primary safety zone of the track
 - (vi) any person who fails to comply with the instructions of the coordinating staff or the regulations governing the conduct of the Event will have their participation in the Event suspended with immediate effect and will be removed from the Circuit area by security personnel
9. I am fully aware that while using the race track, the vehicle may slip, become uncontrollable, slide, spin, or collide with a barrier, tire wall, or another vehicle, and that the kerbs or run-off area may cause damage to the vehicle;
 10. I meet all the requirements necessary to drive the vehicle and possess the necessary and valid documents, which I will present to the Event organizer at the start of the Event;
 11. I acknowledge that, during my participation in the Event, I am solely responsible for ensuring that the vehicle provided by me complies with the technical requirements necessary for participation in the Event.;
 12. I declare that the vehicle used at the Event is technically operational and in a safe condition, with proper steering, braking, and suspension systems, and that the vehicle does not leak fuel, oil, or coolant;
 13. I acknowledge and accept that the Event organizer acting on behalf of HUNGARORING Sport Zrt. and the coordinating staff are entitled to inspect the suitability of the vehicle and/or the participant (in particular the conditions for safe participation), and, **for safety reasons—without any obligation to provide justification—to** refuse participation, suspend participation, or remove the participant from the Circuit premises;
 14. I acknowledge that in the event of an accident, run-off, loss of grip, mechanical failure, or other extraordinary incident, it may be necessary to rescue, tow, remove the vehicle or clean/remediate the track (especially in the event of oil, fuel or coolant contamination);
 15. I acknowledge that if rescue, towing, removal, or damage repair arises in connection with my vehicle, my conduct, or my negligence, I am obligated to bear all associated costs and reimburse HUNGARORING Sport Zrt. for them;
 16. I acknowledge that the above security measures, or the partial or complete cancellation of the Event due to weather/security reasons, do not give rise to any claim for compensation, refund or other compensation on my part;
 17. I acknowledge that my state of health allows me to participate in the Event; I am fit to drive and am not under the influence of alcohol, drugs, or other mind-altering substances, and I do not suffer from any medical condition that would adversely affect my participation in the Event or that may be aggravated by my participation in the Event;
 18. I declare that in the event of **feeling unwell, panic, nausea, or any other health issue**, I will immediately notify the Event organizer and/or the coordinating staff, and I acknowledge that the coordinating staff is authorized to terminate my participation for safety reasons;
 19. I consent to the organizer/coordinating staff acting on behalf of HUNGARORING Sport Zrt. taking the necessary measures in the event of illness, accident, or medical emergency, including providing first aid, calling an ambulance, and providing the necessary minimum information to the healthcare provider; and I acknowledge that the costs of medical care—if not covered by insurance—may be charged to me;
 20. I do not claim any damages against the Event Organizer, its directors, officers, employees, or agents, and I waive any and all claims for damages that may arise; furthermore, by signing this declaration, I also waive my right to challenge or contest the validity of this declaration;
 21. I acknowledge that I am liable for any damage caused by me to any of the Circuit's accessories, at the Circuit's entire area or in the Circuit's facilities (hereinafter collectively: **Facility**), or to any person or property of third parties;
 22. I acknowledge that no insurance is available for the motor vehicle I am driving on the Circuit;
 23. I understand and accept that accidents occurring on the Circuit are not subject to public road traffic regulations, and that collisions are generally regarded as standard racing incidents;
 24. I agree to immediately notify the Event organizer of any personal or property damage caused or discovered during my participation in the Event;
 25. I declare that I will comply with the rules and regulations in force in the area of the Facility, in particular the noise protection regulations, and the instructions of the Event organizer, without disturbing other events taking place at the area of the Facility;
 26. I declare that I have read and accepted the provisions of the Privacy Policy concerning the processing of personal data contained in this declaration.

By signing this declaration, I declare that I have read and understood the provisions set forth above, as well as the provisions of the House Rules to be respected during my stay at the Circuit (<https://hungaroring.hu/site/hu/informacio/hazirend>) were fully and in detail explained to me in advance by a representative or employee of HUNGARORING Sport Zrt. prior to entering the Circuit; I have fully familiarized myself with and understood them, and I will strictly comply with them throughout my entire stay at the Circuit.
